#### RECRUITMENT TO THE ACADEMIC POSITION

The National Institute of Educational Planning and Administration (NIEPA), (Deemed to be University) established by the Ministry of Human Resource Development (now Ministry of Education)), Government of India, is a premier institution dealing with capacity building and research in planning and management of education not only in India but also in South Asia.

In recognition of the pioneering work done by the organization in the field of educational planning and administration, the Government of India have empowered it to award its own degrees by way of conferring it the status of Deemed to be University in August, 2006. NIEPA is fully maintained by the Government of India.

The National Institute has its origin dating back to 1962 when the UNESCO established the Asian Regional Centre for Educational Planners and Administrators which later became the Asian Institute of Educational Planning and Administration in 1965. After 4 years of its existence, it was taken over by the Government of India and renamed as the National Staff College for Educational Planners and Administrators. Subsequently, with the increased roles and functions of the National Staff College, particularly in capacity building, research and professional support services to governments, it was again renamed as the National Institute of Educational Planning and Administration (NIEPA) in 1979.

### Essential Qualifications as per Recruitment Rules, 2020:

A. Master's degree in Education/Management Studies/Social Sciences with minimum of 55% marks (or an equivalent grade in a point scale) from an Indian University, or an equivalent degree from an accredited foreign university.

Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions

in Universities/Colleges / Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The Candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Teaching Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.

B. The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Teaching Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: The Teaching score as specified in Appendix II (Table 3A) for Universities, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

#### **Desirable Qualifications**

Preference will be given to the applicants with:-

- Experience of working as school Head/ School Administrator or in equivalent academic /administrative capacity in the school sector.
- Evidences to illustrate research work in the areas of school education, school administration, management, governance and leadership. Preference will also be given to exceptionally outstanding candidates, specializing in these areas, preferably with minimum Grade A in M.Phil/PhD Programme.
- Experience in organizing seminars/ training and capacity building programmes for school professionals and practitioners.

## **General Condition applicable to Assistant Professor Posts:**

- 1. Eligible candidates may apply for the position only as per the valid format of the Institute uploaded on the website.
- 2. Hard copy of Application can be submitted by courier/speed post or by hand only.

- 3. Candidates currently employed in government/semi government organizations/ autonomous bodies will have to submit No Objection Certificate (NOC) at the time of interview.
- 4. Institute may decide to hold online interviews through video-conferencing. In the event the Institute decides to call candidates to Delhi/NIEPA for interview then, the candidates from outside Delhi shall be paid TA as per 2 AC train fare by shortest route from the address mentioned in the application.
- 5. Minimum requirements of qualifications and/of experience may be relaxed in respect of exceptionally outstanding candidate. The Institute reserves the right to increase or decrease the number of positions, to fill up or not to fill up any or all the posts or to shortlist and select the candidates in any suitable position depending upon the qualification and experience required for the said posts.
- 6. Relaxation in educational qualifications, experience, age, etc. to the reserved category candidates will be permissible as per Government of India rules.
- 7. Reservation of post will be done as per Government of India rules.
- 8. The Institute reserves the right to increase/decrease the number of vacancies.
- 9. The period of contract will be upto 31.03.2022 or co-terminus with the NCSL project.
- 10. Since the post is on short term contract, any claim for confirmation or benefits thereof from NIEPA will not be entertained.
