Overview

The proposed course attempts to engage with the increasing relevance of BRICS (Brazil, Russia, India, China, South Africa) in International political economy. Specifically, it deals with the India-Russia relationship in the changing global order. India has shown a great interest in strengthening bilateral as well as multilateral relations with the members of BRICS bloc. Amongst the members, India and Russia have been known as time tested allies of each other. Both countries share a long history of partnership in multiple fields. With the rise of BRICS and G 20 this partnership is expected to achieve newer heights. However, with the changing nature of global trade environment, increasing challenge of supply chain disruptions, problem of climate change and sustainability, relevance of BRICS in fostering a multipolar world order and its capacity to give new directions to the global economy are being questioned. Besides, there has been significant changes in the domestic environment in both the countries. Both countries are witnessing rise of a new middle class with significant young population contributing to their development. Amidst these changes it is pertinent to assess various fields and their contribution to the bilateral relations between the two countries. This course attempts to engage with these contemporary issues and facilitate capacity building of researchers and policy makers. After attending this course participants will be able to understand how BRICS has been impacting global trade and economy and in what sectors it can contribute in future.
