Minutes of the meeting of the Committee for verification of status of applicants for compassionate appointments were held on 19th May, 2022, 03rd June, 2022 & 4th July, 2022 in Room No. 223, Office of the OSD, JNU.

The Competent Authority had constituted the above three member Committee to examine the documents in respect of the applications received from the applicants who have applied against the compassionate appointment Circular dated 11.01.2021 issued by the University. (Annexure - I)

The University had issued a Circular No. Admn.III/Compt/2020 dated 11.01.2021 inviting applications in the prescribed proforma alongwith required documents in support of their claim for appointment on compassionate grounds for the vacancies earmarked for the year 2019 and 2020. The last date of receiving the applications was 11.02.2021.

In response to this Circular, the University had received 29 applications in the prescribed proforma and the same were placed before the Committee. The University had also received 3 applications for the year 2021 which were submitted by the dependants of the employees who died due to COVID-19. Since no confirmation was received from the UGC for providing 100% appointment to the dependants of COVID deceased employees, these cases were not considered against the vacancies earmarked for the year 2019 & 2020.

The Committee considered the applications, provided by the applicants, as per DoPT norms. (Annexure-II)

- (A) The Distress level was ascertained with the certain indicators like;
 - 1) Year of service left for superannuation of the deceased employee.
 - 2) Reasons necessitating compassion
 - Status of Dependency
- (B) The Comfort level was ascertained with the certain indicators like;
 - 1) Money received
 - 2) Family Pension Received as per 7th CPC
 - 3) Employment Status of the dependants

The Net Distress level = Distress level - Comfort level (A-B)

The details of the compassion Index are as follows:
