NOTIFICATION

In continuation of the University Notifications dated 19.03.2020 &21.10.2020, 01.12.2020, 19.12.2020, 14.01.2021,31.01.2021&12.02.2021,M.H.A order No. 40-3/2020-DM-I(A) dated 30.09.2020, 25.11.2020, 28.12.2020,&27.01.2021, DoPT guidelines dated 13.02.2021. The University has decided Phase-X &XI re-opening of the campus.

- 1. Phase-Xth of Reopening of JNU from 01.03.2021 (Monday): Third Year Science Ph.D students only, and PWD Bachelor and Masters students from all School/Centres (Day Scholars and Hostlers) who require access to the laboratory and other facilities are allowed to enter into the campus.
- 2. Phase-XIth of Reopening of JNU from 08.03.2021 (Monday): All Final Year M.Phil students (Day Scholars and Hostlers) who require access to the campus to submit their dissertation on or before 30.06.2021 are allowed to enter into the campus.
- 3. The re-opening of all authorized Canteens except 'Mugal Darbar' (M/s. Tausif Alam) and (24x07) Food Court (M/s. Jagat Singh) are allowed with immediate effect as per containing provisions of SOP specifically in para 4 (xxiii) in respect of cafeteria/canteen/dining halls, issued by the Ministry of Health & Family Welfare on 13.02.2021.
- 4. The re-opening of Railway Reservation Counter is allowed with immediate effect as per standard operating preventive measures of Government of India rules.
- 5. The re-opening of all authorized service providing shops such as Dhobi, Cobbler, Xerox, Hair cutting Saloon, Canteen of School and Centres etc. are allowed with immediate effect as per standard operating preventive measures of Government of India rules.
- 6. Meetings, as far as feasible, may be continued to be conducted with video conferencing, and physical meetings if absolutely necessary in the interest of students/staff/faculty are allowed with immediate effect as per standard operating preventive measures of Government of India rules which have to be assured by the Dean/Chairperson.
- 7. All are required to strictly follow the preventive measures in respect of COVID-19 notified by the M.H.A./DoPT/MoHFW and University in this regard.
