Course Objectives:

The objective is to understand the ethnic and racial diversity in Canada including its indigenous peoples, its policy of immigration and the evolution of the theory of Multiculturalism. Quebec's significance and its Interculturalism policy is also examined.

Learning Outcomes:

On completion of the course, students will be able to define multiculturalism and debate its effectiveness in Canada; analyse the evolution of Multiculturalism policy. Discuss the history of immigration and understand the diversity of Canadian society including the concept of Diaspora with a focus on Indian Diaspora. The student will also be able to identify different indigenous groups and Canada's policy towards them.

Evaluation Methods:

Class participation (10%); Sessional work (40%); and End-semester Examination (50%)
