A. Objective and Scope of the Programme

The objective of the Program is to support the education of students enrolled in doctoral degree Programmes in the Schools and Centres of Humanities and Social Sciences (School of Social Sciences, School of International Studies, Schools of Languages, Literature & Culture Studies, School of Arts & Aesthetics, School of Sanskrit & Indic Studies, Centre for the Study of Law and Governance and Special Centre for the Study of North East India). It is aimed at identifying and encouraging students with high potential for leadership in national, regional and international affairs, in public life as well as in private endeavors, by awarding fellowships.
